REGULATIONS

REQUIREMENTS

PURPOSE:

To Award Educational Grants to Members in Good Standing and to deserving students who are related to active, retired or deceased members of Locals, Chapters, Associations, Branches, etc within the WESTERN VIRGINIA LABOR FEDERATION. (Related, refers to child, grandchild, step-child or Legally adopted children).

AMOUNT:

Grants will be awarded to qualifying students. Amount to be determined

TIME:

Educational Grants will be awarded at the discretion of the EDUCATIONAL GRANT COMMITTEE.

PLACE:

Winners of the Western Virginia Labor Federationl grants, will be notified by Registered mail.

ACCOUNT:

ALL funds donated to support THE EDUCATIONAL GRANT FUND will be deposited by the Treasurer Into the EDUCATIONAL GRANT ACCOUNT NUMBER 091000025494684 at THE BANK OF AMERICA.

COMMITTEE:

The Western Virginia Labor Federationl, Educational Grant Committee, will consist of four (4) members elected by the Executive Board of the Council. The Committee will then select their chair.

FUNCTION:

The function of the Western Virginia Labor Federation is to establish Rules, Regulations and Requirements governing the Educational grant, as well as to award the Grant to the winning applicants.

ELIGIBILITY:

Applicants must be a member in good standing, either active or retired, the spouse, son, daughter or a legally adopted child, step-child, or grandchild of a member in good standing, working, retired or deceased. The APPLICANT must possess either a High School diploma or G.E.D. equivalency. Unless the applicant is currently enrolled as a High School senior.

SCHOOLS:

Competing applicants must provide evidence of their acceptance at an accredited institute of higher Learning (post High School) or a certified Technical/vocational School. Applications will be made available to local affiliates at the September meeting of the Western Virginia Labor Federation.

APPLICATION:

Candidates must submit applications for award of the Western Virginia Labor Federation Educational Grant to the Educational Grant Committee, 2101 Dale Avenue, S.E., Roanoke, VA 24013-1909.

PERSONAL BIOGRAPHY:

Applicants must submit a personal biography detailing what the applicant hopes to accomplish in the Academic or Technical Field of endeavor that they have chosen.

SUPPORTING DOCUMENTS:

Applicants are required to furnish the following information with their application.

- (A) Copy of SCHOLASTIC APPTITUDE TEST (SAT) OR AMERICAN COLLEGE TEST (ACT).
- (B) Secondary school scholastic records.
- (C) PERSONAL BIOGRAPHY TO INCLUDE:
 - (1.) Subject in which student intends to major.
 - (2.) Why the student is interested in this major.
 - (3.) What the student hopes to accomplish in this field.

DEADLINE:

All applications and supporting documents must be postmarked by midnight January 15, 2010. Same date Following years.

AWARDS:

Winners are selected on the basis of personal qualifications, secondary school records, financial need and timely provision of supporting documents. The Official Educational Grant Judges will be appointed by the Executive Board. There shall be a minimum of three Judges on the panel.

FUNDS:

Educational Grant Funds will be derived from fund-raising donations, memorials, and compound interest From the Educational C.D.'s. (Certificate of Deposits). Contributions to the Grant Fund are NOT tax deductible. Funds will be recorded and administered by the Secretary-Treasurer with the approval for deposit and disbursement by the Educational Grant Committee. Expenses, if any, will be covered by the Educational Grant Funds. (e.g. bonding) The Western Virginia Labor Federation Educational Grant Committee will meet as often as necessary to faithfully perform the duties of administering this Educational Grant Fund for deserving applicants.

REGULATIONS:

- 1.) Award money must be used for required College or Technical School fees and for related school Expenses, including room and board incurred within 12 months from the date of the award.
- 2.) Winners may accept other scholarships or grant assistance in addition to this award.
- 3.) If a winner suffers a certified serious illness, the grant will be held in abeyance for not more than one year.
- 4.) If the member withdraws from his or her Union, the grant (award) will be cancelled. (This provision does not apply to members relatives).
- 5.) If the winner does not attend school within a twelve (12) month period following the date of the award, the grant will be withdrawn and awarded to alternate applicant(s).
- 6.) Satisfactory grades should be maintained.
- 7.) School transcripts may be required by the Committee.
- 8.) Educational Grant winners and applicants may re-apply every year the award is available; but only one award per applicant, per calendar year is permitted.
- 9.) Educational Grant award winners are responsible for all tax regulations.
- 10.) The personal biography should detail what the Applicant hopes to accomplish in the Academic or Technical field of endeavor they have chosen, as well as a description of their financial status or household income to support their request for Grant money. All information submitted will remain strictly confidential.
- 11.) All applications and awards may be destroyed twelve (12) months after the date of award at the discretion of the Educational Grant Committee
- 12.) Disbursement of Award:
 - 1.) Award money will be deposited with the school of recipients' choice and credited to the student's account to be drawn upon under the rules and regulations which the school has established for handling Grant Funds.
 - 2.) Award money will remain on deposit with the Bank of America, in the Western Virginia Labor Federation AFL-CIO Educational Grant account number 091000025494684. Grant award winners will draw upon this account, up to the maximum amount of their award.
